WE TAKE OUR CUSTOMER AND STAFF HEALTH AND WELLBEING VERY SERIOUSLY AND WE WOULD ASK EVERYONE TO ADHERE TO THESE RULES WHILST ON SITE.

ALL ON-SITE MARSHALS/ STAFF HAVE RECEIVED ADDITIONAL TRAINING IN RELATION TO COVID-19.

THE FOLLOWING IMPLEMENTATIONS ARE DONE SO WITH THE HEALTH OF OUR CUSTOMERS AND STAFF IN MIND. PLEASE TAKE NOTE OF ALL REQUIREMENTS AND PROCESSES BELOW:

HEALTH & HYGIENE:

- KEEP A MINIMUM OF 2 METERS FROM OTHERS WHERE POSSIBLE
- WEAR A FACE MASK WHEN COMING WITHIN 2 METERS OF ANOTHER PERSON
- LIMIT CLOSE SOCIAL INTERACTION WHEN POSSIBLE
- COVER YOUR MOUTH AND NOSE WHEN SNEEZING OR COUGHING (CATCH IT, BIN IT, KILL IT)
- MAINTAIN A HIGH LEVEL OF HYGIENE
- WASH HANDS REGULARLY BASED ON THE GOVERNMENT GUIDELINES

MANDATORY PERSONAL EQUIPMENT:

IN ADDITION TO NORMAL EQUIPMENT REQUIRED THE FOLLOWING ITEMS ARE MANDATORY.

- HAND SANITISER (70% ALCOHOL-BASED GEL)
- DISINFECTANT / ALCOHOL WIPES
- FACE COVERING / MASK (WITH REPLACEMENTS)
- WASH KIT & TOILETRIES
- PERSONAL FIRST AID KIT
- TOILET PAPER
- RUBBISH / REFUSE BAGS

ARRIVALS

ON ARRIVAL A SCREENING AND HEALTH CHECK WILL TAKE PLACE. THIS WILL CONSIST OF THE FOLLOWING:

- CUSTOMER ARRIVES AND STAYS INSIDE THEIR VEHICLE.
- A MEMBER OF STAFF WITH APPROPRIATE PROTECTIVE EQUIPMENT WILL APPROACH VEHICLE.
- TEMPERATURES ARE TAKEN BY ALL OCCUPANTS OF THE VEHICLE USING A NON-CONTACT THERMOMETER.
- THE FOLLOWING QUESTIONS WILL BE ASKED TO ALL OCCUPANTS OF THE VEHICLE FOR CONFIRMATION:
 - CUSTOMER HAS NOT DISPLAYED ANY SYMPTOMS OF COVID-19 IN THE LAST 21 DAYS
 - SOCIAL DISTANCING WILL BE ADHERED TO
 - CUSTOMERS WILL WASH HANDS REGULARLY
 - CUSTOMERS WILL WEAR FACE MASK WHEN REQUIRED
 - CUSTOMERS WILL CARRY PERSONAL HAND SANITISER
 - CUSTOMERS WILL AGREE TO ABIDE BY ALL OTHER COVID-19 SAFETY MEASURES
